The Edwin B. Hogan Memorial Scholarship Program includes:

- \$5,000.00 scholarship for students of Black/African Descent in the Civil Engineering, Architecture and Planning Fields with a focus on Community Involvement.

To be eligible for this scholarship program, applicants must:

- Black/African Descent
- Enrolled in an Accredited Ohio College or University in the Civil Engineering, Architecture and Planning Field(s)
- Strong Community Involvement

One of Ed's most impactful characteristics was his ability to build long-term collaborations and bridge gaps by helping people make connections that prove to be mutually beneficial. Ed's profound success hinged on his philosophy: "It is one thing to have a long list of contacts, but knowing how to link people is key."

Throughout his career, Ed was a strong advocate for what he recognized as the need to educate more African American young people about careers in lobbying. Through his involvement with the 100 Black Men of Central Ohio, Ed was involved in a mentoring program that included government affairs. "We want to encourage young people to get involved," he said, "because in the political process you're either a player or a victim." Ed received numerous accolades, awards, and commendations. He also served on boards of trustees or contributed time and resources to a number of organizations, including Maryhaven, Inc., Alvis House, Muscular Dystrophy Association, Ballet Met and Columbus Metropolitan Area Community Action Organization (CMAO). However, when asked his greatest accomplishment, Ed responded, "Adopting an elementary school and receiving the Golden Ruler Award from the Columbus Public School System."

Application Requirements

- Demonstrate a commitment to giving back, community involvement and volunteerism.
- Be enrolled in an accredited Ohio College or University Undergraduate Civil Engineering, Architecture or Planning program.
- Be of Black/African descent
- Complete application
- Submit Official Transcript
- Complete essay on the role of giving back to the applicant's community, including examples of how the applicant has given back.
- Provide two Letters of Recommendation
- Provide contact information for one Academic Reference
- Provide contact information for one Community Activism Reference
- Include Résumé

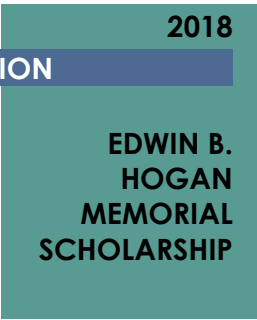
Application Process

- We consider applications on a rolling basis. You are encouraged to apply as soon as possible to be considered for awards beginning in August. The application is a multi-step process.
- Only completed applications will be considered.
- The ability to do a phone and in person interview with the Scholarship Committee is required.

- Upon submission, application will be reviewed for completeness. If complete, application will be submitted to the Scholarship Committee. If approved by a majority of Committee members, applicant will be contacted to schedule a phone interview. In some cases, multiple interviews may be conducted. Finally, at the discretion of the Scholarship Committee, an in-person interview may be conducted. Applicants will be notified of Committee decisions no later than August 15th of each application year.

Post Award Expectations

- Scholarship funds will be awarded directly to the school through the bursar's office in the student's name.
- The ability to participate in publicity events, including, but not limited to Press Release(s), photoshoots, Press Conference, and act as an ambassador of the scholarship program is highly encouraged. Release signature for Press Releases, social media and online posting announce the scholarship award are required.
- Opportunities for interning and mentoring programs may be available.
